WHEREAS, the Director of I.T. and Facilities, by memorandum, dated February 2, 2022, advises that the above-referenced Project has been completed and recommends acceptance of the Contract; and,

WHEREAS, Meggitt Training Systems, Inc. has submitted a one-year Maintenance Bond in accordance with the terms of the bid specifications;

NOW, THEREFORE, BE IT RESOLVED that the Township Committee of the Township of Freehold, based on the above referenced recommendations, accepts the public project known as Contract 20-15 Police Shooting Range Facility Improvements and authorizes final payment be made to Meggitt Training Systems, Inc.;

WHEREAS, the Township of Freehold has a need for services relating to the coordination and billing of off-duty employment of police officers for police related activities; and,

WHEREAS, the Township utilizes Police Officer Scheduling System produced by VCS Human Capital Management for the scheduling of Police Officers; and,

WHEREAS, N.J.S.A. 40A:11-5(1)(dd) provides for the provision or performance of goods and services for the support or maintenance of proprietary computer hardware and software: and,

WHEREAS, Jobs4Blue, a subsidiary of VCS Human Capital Management currently handles scheduling of Officers for off-duty work, has proposed a contract to provide the needed service for the off-duty work to include all scheduling as well as the collection of fees due to the Township, at no cost to the Township, by charging the outside organizations who request the service an administrative fee of eight (8%) percent of the costs charged and paid to the Township;

NOW, THEREFORE, BE IT RESOLVED that the Township Committee of the Township of Freehold herein authorizes the execution of a Contract between the Township of Freehold and Jobs4Blue for the coordination of billing of off-duty employment of police officers for police related activities,

## **- - - R E S O L U T I O N - - -**

WHEREAS, the Township of Freehold has a need for Offsite Record Storage as a non-fair and open contract, pursuant to the provisions of N.J.S.A. 19:44A-20.4 or 20.5 as appropriate; and,

WHEREAS, the Purchasing Agent has determined and certified in writing that the value of the acquisition will not exceed that Township's bid threshold, but will exceed \$17,500.00 in vendor aggregation; and,

WHEREAS, the anticipated term of this contract is one year; and,

WHEREAS, GRM Information Management Service can supply the Township with the required services for a cost not to exceed \$35,000.00; and,

WHEREAS, GRM Information Management Service has completed and submitted a Business Entity Disclosure Certification which certifies that GRM Information Management Service has not made any reportable contributions to a political or candidate committee in the Township of Freehold, County of Monmouth, in the previous one year, and that the contract will prohibit GRM Information Management Service from making any reportable contributions through the term of the contract; and,

WHEREAS, the Director of Finance has certified to the Township Clerk that funds are available in the following Budget Accounts contingent upon the necessary funds being appropriated by the Governing Body in the 2022 and 2023 Municipal Budgets:

**TITLE: RESOLUTION AUTHORIZING THE COUNTY OF MONMOUTH MOSQUITO CONTROL DIVISION TO CONDUCT AERIAL MOSQUITO CONTROL OPERATIONS WITHIN THE TOWNSHIP OF FREEHOLD**

## **- - - R E S O L U T I O N - - -**

WHEREAS, the Monmouth County Board of Chosen Freeholders, pursuant to NJSA 26:9-27 et seq. has elected, through its Mosquito Control Division, to perform all acts necessary for the elimination of mosquito breeding areas and/or to exterminate mosquitoes within the County; and,

WHEREAS, the County has instituted an Integrated Pest Management Program consisting of surveillance, water management, biological control, and chemical control to exterminate the mosquito population within the County of Monmouth; and,

WHEREAS, prior to conducting aerial dispensing operations over a designated "congested area," the County is required, pursuant to Federal Aviation Administration Regulation (FAR Part 137.51), to secure prior written approval from the governing body of the political subdivision over which the aircraft is to be operated; and,

WHEREAS, the Township of Freehold is designated as a "congested area" by the Federal Aviation Administration, and the County has requested that this Governing Body consent to its proposed aerial dispensing operations;

NOW, THEREFORE, BE IT RESOLVED as follows:

1. The Governing Body hereby authorizes the County of Monmouth Mosquito Control Division or its agent to apply pesticides by aircraft for mosquito control in certain areas of the Municipality designated by the County as being either larval mosquito habitat or areas harboring high populations of mosquitoes constituting either a nuisance, a health hazard, or both, with the understanding that:



- a. the County shall utilize pesticides, application equipment and aircraft that are approved for aerial applications by the applicable Federal (USEPA) and State (NJDEP) agencies, and
- b. such operations will be performed in compliance with applicable Federal and State regulations, and
- c. the County will notify the police department of each municipality over which aerial pesticide operations are planned prior to commencement of such operations.

BE IT FURTHER RESOLVED that a certified copy of the within Resolution shall be forwarded to Victoria Thompson, Superintendent, Monmouth County Mosquito Control Division, 1901 Wayside Road, Tinton Falls, NJ 07724; the Freehold Township Police Chief; the Freehold Township Health Officer; the Freehold Township Public Works Superintendent and the Freehold Township Superintendent of Parks and Recreation.
