**REVIEW OF MINUTES:** Cookie approved the minutes from January meeting and

**CORRESPONDENCE:** Miscellaneous correspondence from MCHC.

**NEW BUSINESS**: Joe introduced the project of revising the Historic Resource Report as the original is dated 1989, and many of the properties are either no longer extant, or have been altered. He asked for a three-person committee to complete it by June 30, 2022. Michael volunteered to photograph the listings. Cookie advised criteria such as current owner status and block and lot verification. Joe will request an introductory letter issued by the Township for presentation to homeowners. David and Todd volunteered as well. Which introduced the subject of photo IDs for the Commission. Joe will arrange.
