

Meeting Minutes: Freehold Township Board of Health

September 12, 2019

REGULAR MEETING

Opening

1) Call to Order

The September 12, 2019, regular meeting of the Freehold Township Board of Health was called to order by Chairwoman Ms. Lemesevski at 6:40 PM. Board members present included: Mrs. Weissman, Dr. Apolito, Dr. Reilly, Mr. Ammiano and Chairwoman Lemesevski. Absent: Dr. Opatut, Mr. Chudkowski, Ms. Allen and Mrs. Porth. Also present: Margaret Jahn, Health Officer, and Jennifer McAuley, Recording Secretary.
